2. THE BOARD OF ALDERMEN WILL CONSIDER ADOPTING

RESOLUTION # 6 of 2020 (inadvertently listed as Resolution # 5 on the Agenda) **OF THE TOWN OF VIVIAN –** A RESOLUTION AUTHORIZING MAYOR FESTAVAN TO ENTER INTO AN AGREEMENT(S) WITH THE UNITED STATES OF AMERICA (acting through the Federal Aviation Administration, herein called the 'FAA') AND SIGN THE CARES (Coronavirus Aid, Relief, And Economic Security) ACT AIRPORT GRANT AGREEMENT(S). REVIEW AND CONSIDERATION OF PROPOSED UTILITY (Water & Sewer) AND STREET DEPARTMENTS BUDGETS for FISCAL YEAR 2020-21 – Public Works Director, Kevin Hartzo was also in attendance to participate in the FY 2020-21 Budget process by presenting the proposed budget for the Utility (Water & Sewer) and Street Departments in the coming year. Following Mr. Hartzo's presentation of his Departments' proposed budgets, discussion was held between Council Members, Mayor Festavan and Mr. Hartzo, and the decision was made to workup additional budget figures and make it available to Mr. Hartzo before the next Budget Workshop meeting also.
