SPECIAL CALLED TOWN COUNCIL MEETING VIVIAN TOWN HALL MEETING ROOM 112 W. ALABAMA AVE. VIVIAN, LOUISIANA THURSDAY, JANUARY 5, 2023 4:30 P.M.
